Allen Zagarell Policy Statement

I am a strong supporter of the principles of the AAUP. The right to be heard and to participate in decision making is a matter of basic dignity. I believe the right of collective bargaining is the guarantee of those rights. I believe in an active organization interested in organizing, that extends the right of collective bargaining to our colleagues. I believe in faculty speaking out about the issues that affect their lives and our nation's educational policy. For example, I strongly support the active cooperation betwee the AAUP and the AFT in organizing new collective bargaining chapters in various states.
