

Record of the Council June 16 and 18, 2017

The Council of the Association met June 16 and 18, 2017, at the Mayflower Hotel in Washington, DC. President Rudy H. Fichtenbaum presided. Participating were members of the Council (with the exception of Jacqueline Aranté, Zoran Gajic, Sonya Hester, Cynthia Klekar, and Mehmet Yaya), parliamentarian Kerry Grant, general counsel Risa Lieberwitz, executive director Julie M. Schmid, and members of the AAUP staff. President Fichtenbaum called the meeting to order on June 16, 2017, and introduced the parliamentarian and new members of the national AAUP staff. The Council adopted its agenda and approved the minutes of prior meetings.

Report of the Secretary-Treasurer

On June 16, secretary-treasurer Michele Ganon gave a detailed summary of the FY2016 audit report and the results of the audit. The Council accepted the Association's FY2016 audit report. She also reported on the AAUP's financial position and investments.

Report of Committee A on Academic Freedom and Tenure

Henry Reichman, chair of Committee A on Academic Freedom and Tenure, presented the committee's report to the Council. He referred to Committee A's statements recommending to the 103rd Annual Meeting that it place the Community College of Aurora (Colorado) and Spalding University (Kentucky) on the Association's list of censured administrations as well as its statements recommending to the 103rd Annual Meeting that it remove Phillips Community College of the University of Arkansas and the University of Illinois at Urbana-Champaign from the Association's list of censured administrations. The Council concurred in the two recommendations for censure and the two recommendations for removal of censure.
