The Council of the Association met November 18 and 19, 2017, at the Doubletree Hotel in Arlington, VA. President Rudy H. Fichtenbaum presided. Participating were members of the Council (with the exception of Sonya Hester, David Hughes, Cynthia Klekar, Julian Madison, and Mehmet Yaya), parliamentarian Kerry Grant, general counsel Risa Lieberwitz, executive director Julie M. Schmid, and members of the AAUP staff. President Fichtenbaum called the meeting to order on November 18, 2017, and introduced the parliamentarian and new members of the national AAUP staff. The Council adopted its agenda and approved the minutes of prior meetings.
